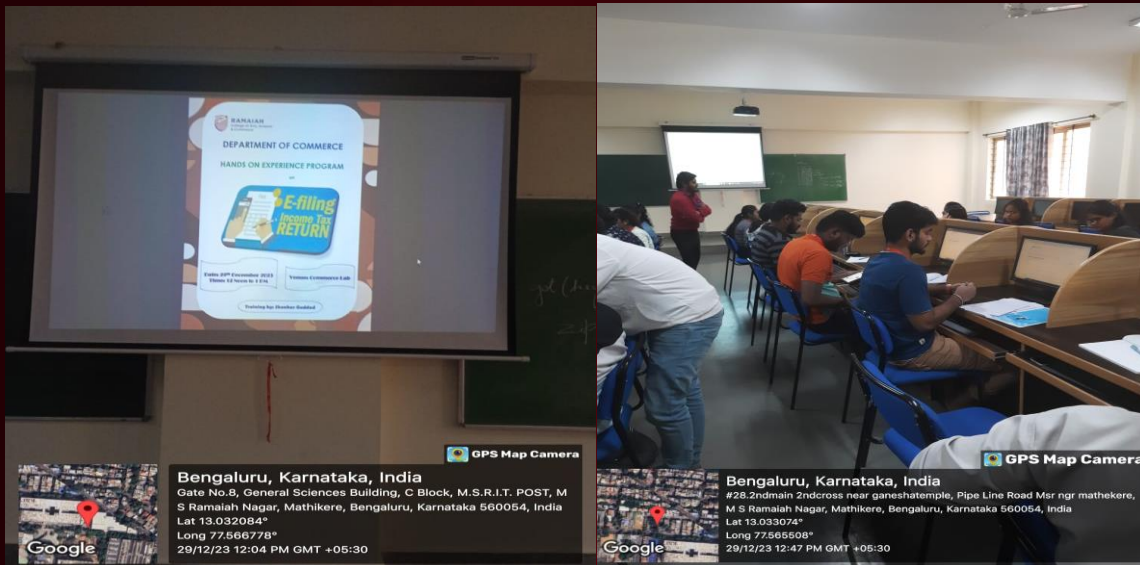
VIGILANCE AWARENESS WEEK
