# Eligibility Criteria





1. Scholarship for Fresh & Renewal will be awarded to the students **who have secured not less than 50% of marks** or equivalent grade in the last annual Board/Class examination with a pass certificate. (Not applicable for students studying in 1st std).
2. The **annual income** of the students' Parents/ Guardians from all sources should not exceed as mentioned below under each scheme
  - ✓ Rs.1 Lakh for Pre-Matric Scholarship.
  - ✓ Rs.2 Lakh for Post Matric Scholarship.
  - ✓ Rs.2.5 Lakh for Merit Cum Means / Top Class Scholarship.
3. **Students of Karnataka** domicile studying in other states are also eligible to apply in Karnataka.
4. Scholarships under each scheme are sanctioned **only based on Admission fees & Tuition fees.**

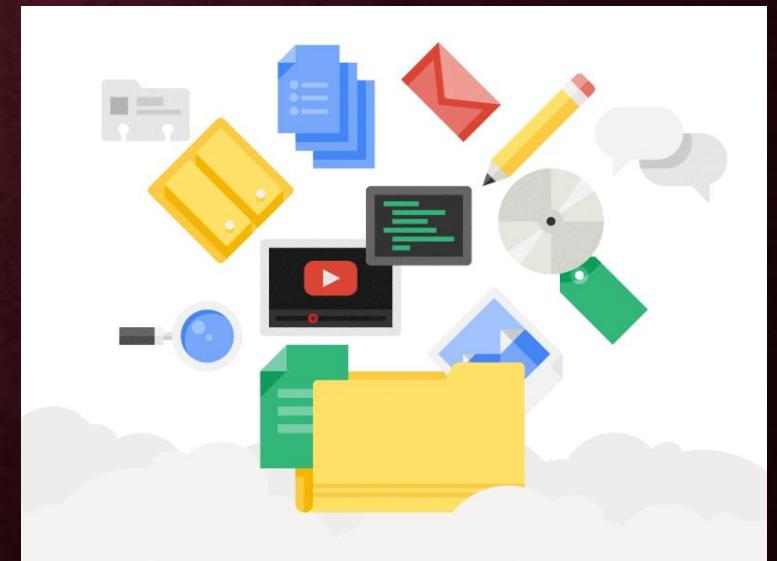
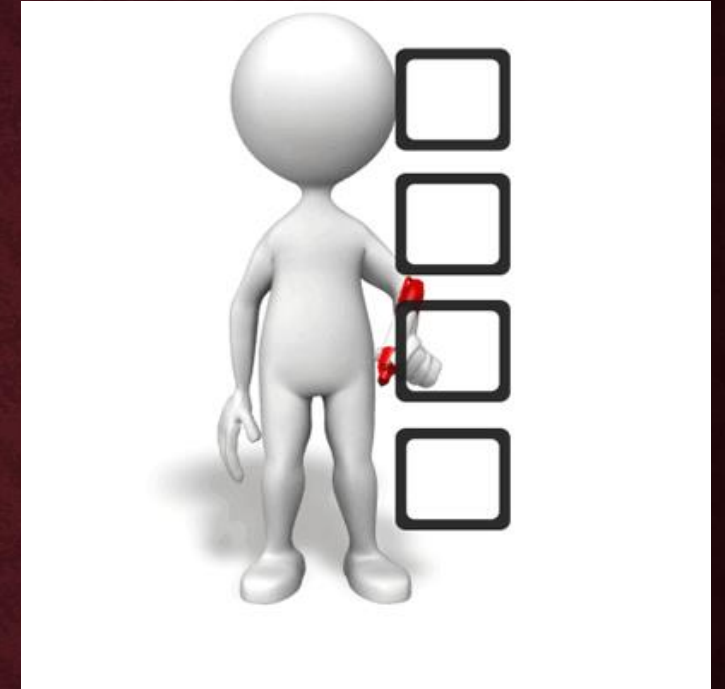
5. Students **pursuing correspondence education and certificate courses or training are not eligible.**
6. Students of **other states studying in Karnataka** are not eligible to apply from Karnataka.
7. Students should submit their **hardcopies of online application** along with documents to their **respective schools/colleges.**
8. Students whose application is **not forwarded online to next level by the Head Master/Principal of the institute, schools, and colleges are not eligible for scholarship.**
9. **Merit Cum Means** students should **upload the required**
10. **Valid income** and **caste certificate** is required.

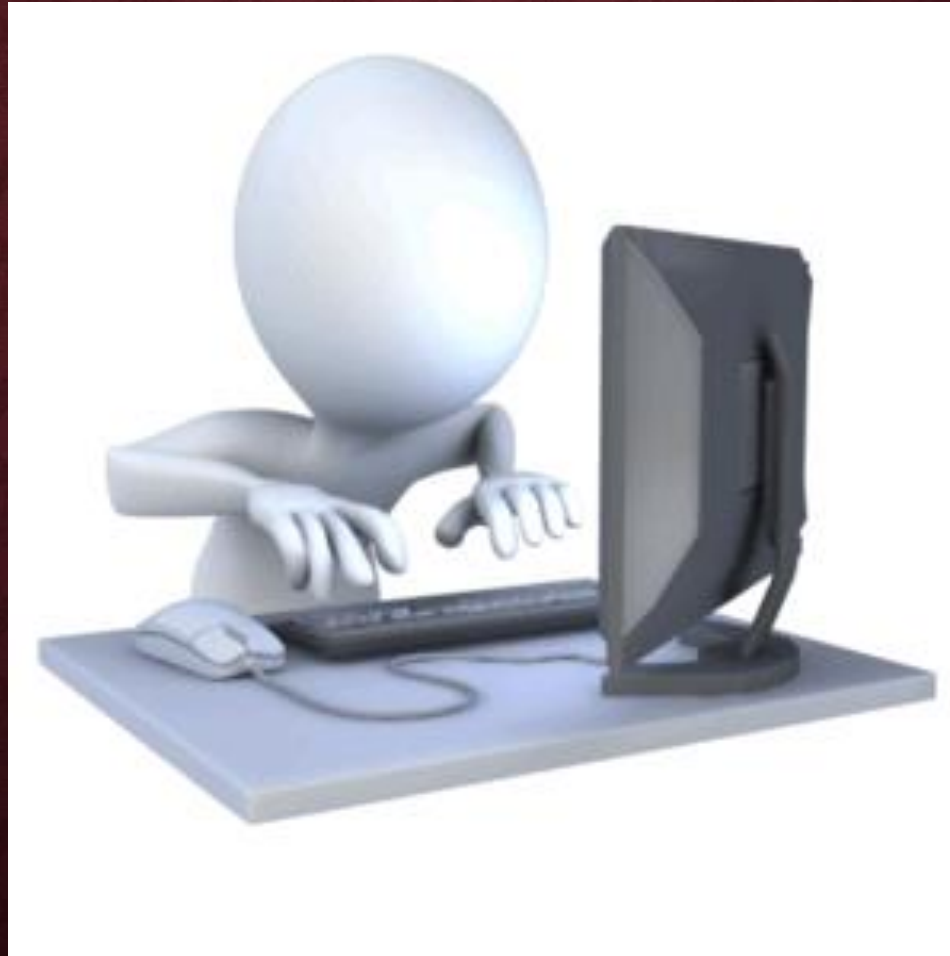

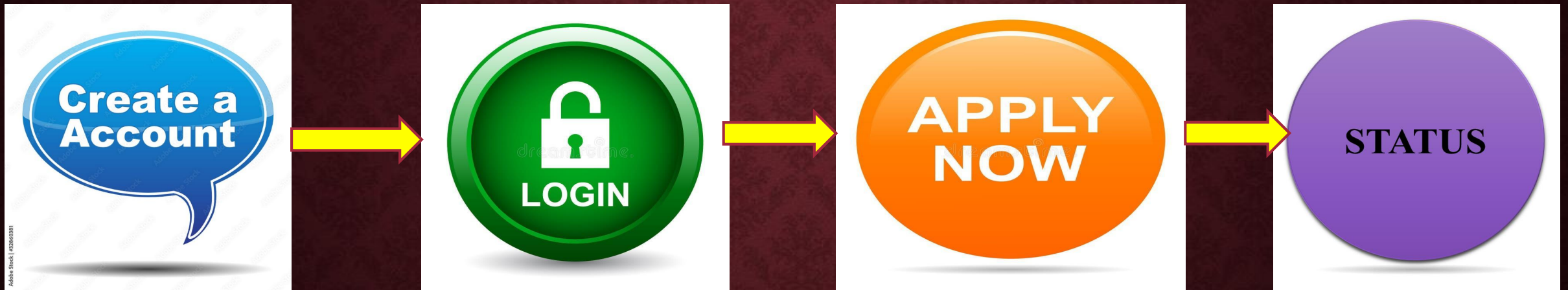

**SSP Karnataka Apply Online 2023: To create an account on the SSP Scholarship Portal, follow these steps:**





1. Visit the official website at [www.ssp.postmatric.karnataka.gov.in](http://www.ssp.postmatric.karnataka.gov.in).
2. Click on 'Create Account' on the home page.
3. Choose your plan and caste.
4. Fill in your Aadhaar number and other details.
5. Verify your mobile number through the OTP sent.
6. Complete the rest of the details, including ration card details.
7. Set a password to create your account successfully.

**How to do Student Login in SSP Scholarship Portal: For student login on the SSP Scholarship Portal, follow these steps:**





1. Go to the online portal.
2. Click on 'Student Login' on the home page.
3. Enter your username and password.
4. Fill in the captcha code and click on login to access the portal.

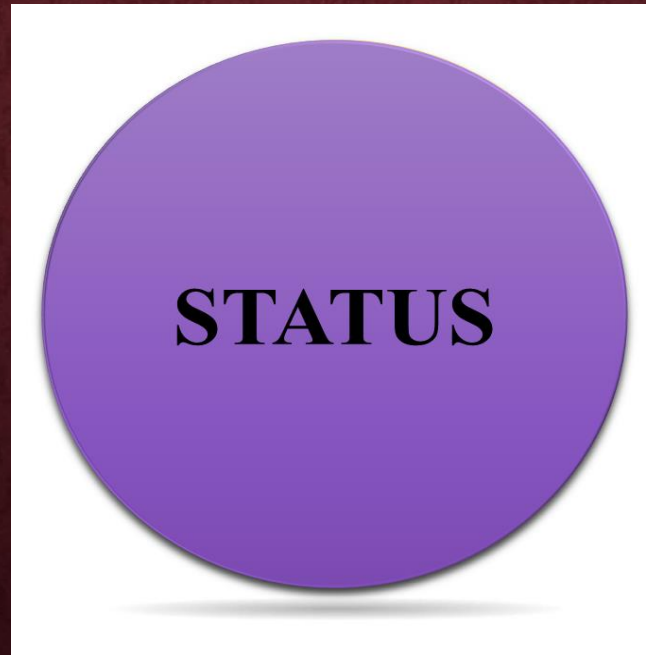


**SSP Karnataka Scholarship Online Application: To apply

5. Upload all the necessary documents.
6. Submit the application form.

3. Enter the SATS Identification Number of the student.
4. Select the financial year and click on search to view the status.

1. Multiple scholarships are made available through this scheme.

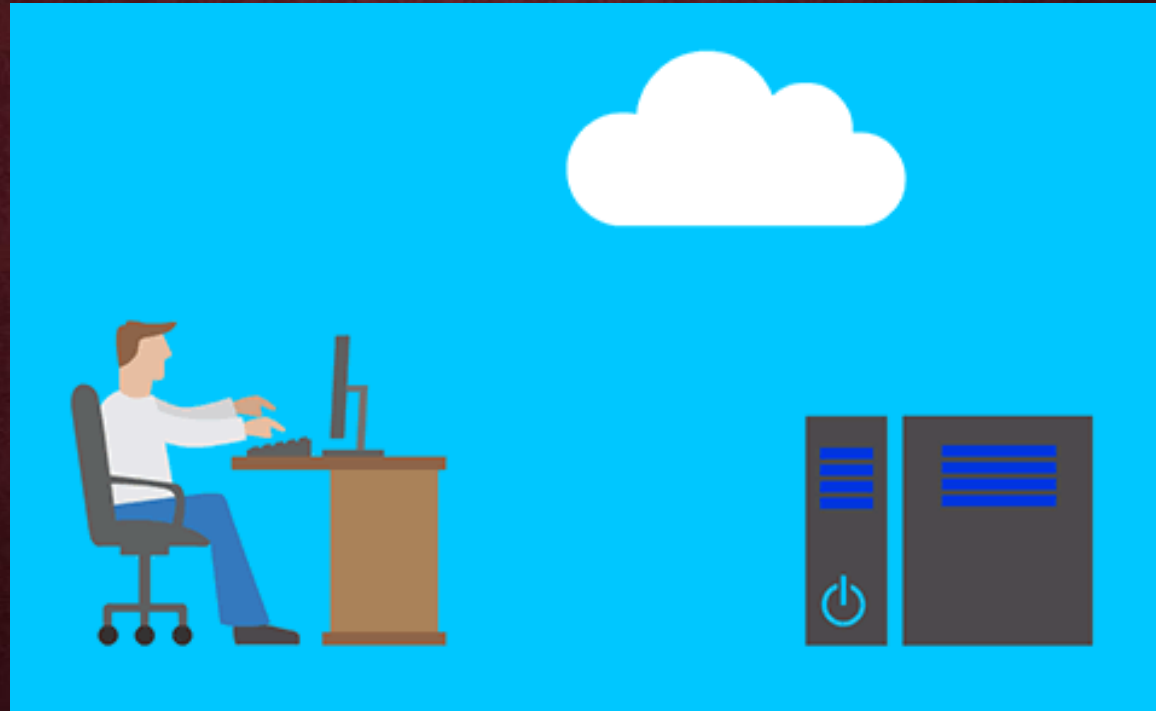




2. The application process is simple and can be completed online.



3. The scholarship amount is directly transferred to the beneficiary's bank account.

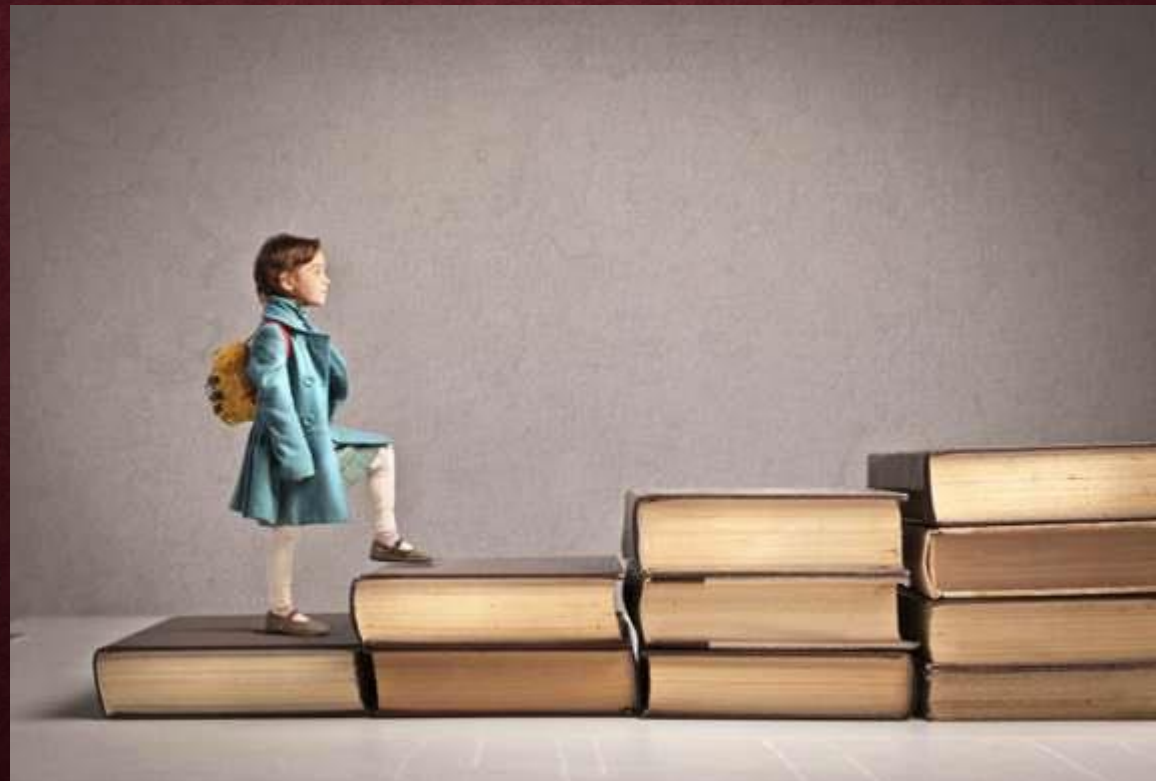


4. It aims to help students continue their education without financial constraints.

# Key Details:



Scholarship Amount: ₹25,000 per year for up to 3 years



# Eligibility Criteria :



- Female students pursuing BBA, BCA, or BMS courses
- Family income less than ₹8 lakh per annum
- Only two girl children from the same family are eligible

# Selection Criteria:



Based on Class 12 marks

# Application process:



Online through the National Scholarship  
Portal (NSP) or AICTE official website



# Important Dates:



- Application Deadline: February 28, 2025 (for the academic year 2024-25)
- Scholarship Disbursement: June 2025

# Benefits:



- Financial assistance for tuition fees, books, and study materials
- Supports girls from middle-class and lower-income families in pursuing higher education



# Number of Scholarships:



3,110 scholarships are awarded annually, with 1,550 for BBA/BMS programs and 1,560 for BCA programs.
